- II AGE: 18-27 years as on 01.04.2024 Relaxation to reserved category as per guidelines in this regard.
- III RESERVATION OF VACANCIES: Guidelines on reservation for SC/ST/OBC under Apprentices Act and Mormugao Port Authority will be followed. Those candidates who are claiming reservation under SC/ST/OBC shall provide a certificate. in this regard, failing which their claim for reservation will be considered as "General" category only.
- IV. DURATION OF TRAINING: The duration of Apprenticeship training will be for a period of one year as per Apprentices (Amendment) Act, 1973.
- V. SELECTION PROCEDURE: The final rank list would be prepared according to categories General/SC/ST/OBC on the basis of marks obtained by the candidates, The Selection will be made from the candidates who fulfill the minimum standard educational qualification and medical fitness.
- VI. Only those candidates will be considered for the apprentice engagement who are based at Goa.
- VII. The eligible candidates must be registered/enrolled on www.apprenticeshipindia.gov.in or www.apprenticeshipindia.org. For queries related to student enrollment in web portal, you may please contact Regional Director of Skill Development & Entrepreneurship, Mumbai.
- VIII. BOARDING/LODGING/TA/DA: No boarding or lodging expenses are admissible. No TA/DA will be paid for attending interview and certificate verification or during apprenticeship training.
- IX. MPA will not be responsible for the regular appointment after completion of apprenticeship training.
- X. The interview call letters to eligible candidates will be sent by Post on registered address one week in advance. MPA shall not be responsible if call letters are not delivered in time by post.
- XI. LAST DATE FOR SUBMISSION OF APPLICATION (ONLINE/OFFLINE) To "MORMUGAO PORT AUTHORITY" is 19.07.2024
- XII. INCOMPLETE/ERONEOUS ONLINE APPLICATION RECEIVED WILL BE REJECTED.
- XIII. No Trade Certificate holder who had training or job experience for a period one year or more, after the attainment of these qualifications shall be eligible for being engaged as an apprentice under the Act.
- XIV. A person who has been a Trade apprentice under the Act and in whose case the contract or apprenticeship was terminated for any reason whatsoever shall not be eligible for being engaged as an apprentice again under the Act without the prior approval of the Apprenticeship Adviser.

- XV The candidature of applicant would be provisional and subject to subsequent verification of certificates and testimonials. In case, it is detected at any stage of engagement or thereafter, that a candidates does not fulfill the eligibility norms and or/that he/she has furnished any incorrect/false information/certificate/documents or has suppressed any material etc. his/her candidature will stand cancelled.
- XVI. At any point (i.e. even after joining) if found ineligible as per the given criteria, your candidature will be terminated with immediate effect.
